Important Rates and Disclosures

Interest Rates and Interest Charges

Annual Percentage Rate (APR) for Purchases

- **APR Range:** 7.99% - 27.99%
 - Your APR will be determined based on your creditworthiness at the time of account opening.

APR for Balance Transfers

- **APR Range:** 7.99% - 27.99%
 - This will match your purchase APR and vary based on your creditworthiness at account opening.

APR for Cash Advances

- **Cash Advance APR:** 27.99%

Penalty APR and When It Applies

- **Penalty APR:** 29.99%
 - This APR may be applied to your account if you:
 - Make a late payment.
 - Make a payment that is returned.
 - **How Long Will the Penalty APR Apply?**
 - The Penalty APR will remain in effect until you have made six consecutive minimum payments by the due date.

Fees

Annual Fees

- **Annual Fee:** \$95

Transaction Fees

- **Balance Transfer Fee:** 3% of the amount of each balance transfer (\$5 minimum)
- **Cash Advance Fee:** 5% of the amount of each cash advance (\$10 minimum)
- **Foreign Transaction Fee:** 3% of each transaction in U.S. dollars

Penalty Fees

- **Late Payment Fee:** Up to \$40
- **Returned Payment Fee:** Up to \$40

Minimum Interest Charge

- If you are charged interest, the charge will be no less than \$1.50.

How to Avoid Paying Interest on Purchases

- Your due date is at least 25 days after the close of each billing cycle. We will not charge you interest on purchases if you pay your entire balance by the due date each month.
